If approved the initial fee, and any inspection fees thereafter, shall be credited to the general operating fund of the city. 1 % of total estimated gross building cost \$100.00 minimum when estimated cost is under \$10,000. In the event the inspection costs and fees involved exceed the initial building permit fee, the applicant will be responsible for any costs in excess of the initial fee. These costs in excess of the initial building permit fee will be composed of the cost of the inspection plus an additional \$10.00 for processing per inspection.
